Dear Valued Abbott Point of Care Customer,

This letter contains important information regarding the *i-STAT EG6+* cartridge with the *i-STAT 1 System*.

The *i-STAT EG6+* cartridge with the *i-STAT 1 System* is intended for use in the *in vitro* quantification of sodium, potassium, hematocrit, pH, partial pressure of oxygen (*P*O₂), and partial pressure of carbon dioxide (*P*CO₂) in arterial, venous or capillary whole blood.

Abbott Point of Care has made the decision to discontinue the *i-STAT EG6*+ cartridge for use with the *i-STAT 1 System*. The *i-STATEG7*+ and *CG8*+ cartridges are available on the *i-STAT 1 System* and may be considered as alternative cartridges for your facility. Abbott Point of Care is providing this information in advance to support your planning process and help ensure a smooth transition to an alternative solution that meets your testing needs.

The *i-STAT EG7*+ and *i-STAT CG8*+ cartridges have the same intended use as the *i-STAT EG6*+ cartridge, with the following differences:

- *i-STAT EG*7+ also includes ionized calcium (iCa) as an additional analyte.
- *i-STAT CG8*+ also includes ionized calcium (iCa) and glucose as additional analytes.

Abbott Point of Care will stop shipment of the *i-STAT EG6+* cartridge on March 31, 2027. *i-STAT EG6+* cartridges can continue to be used until the specified expiration date on the product label.

RECOMMENDED ACTIONS:

Please transition to another available *i-STAT* cartridge that offers the range of tests needed on the *i-STAT 1 System*. When transitioning to another *i-STAT* cartridge(s), facilities should follow their own policies and procedures for handling validation testing, if required.
